Include business support about Land Permit in the Land Reform by Agricultural Land Reform Office, Ministry of Agriculture and Cooperative of Thailand. In the past land was used in other business. As a result, the land is reduced. With Section 19 (6) (12) and Section 30 (Fifth paragraph) with Agricultural Land Reform Act B.E. 2518 (1975). Determined can make other business without Agricultural but that business must support or related to the purpose of Agricultural Land Reform by Agricultural Land Reform Executive Committee. Is defined as Regulations of Agricultural Land Reform Executive Committee assign to Secretary-General of Agricultural Lan Reform Office. Consider Land Permit for Public utilities business and other. In the Land Reform B.E. 2536, there are requirements many types of business and have announce form Ministry of Agricultural Land Cooperative. About other business that support or related to the purpose of Agricultural Land

Reform by Section 30 (Fifth paragraph) with Agricultural Land Reform Act B.E. 2518 (1975). The regulations and announcements set out various business. Some business are not related to agriculture. Such as wind wheel Telephone Pole Official Place etc. As a result, the area of the Agricultural Land Reform Office. It is not used to the benefits of Agricultural. Even the problem is less compared to all. If can maintain they Agricultural area, easy to maintaining an area for other agricultural too.

As a way to solve the problem. The authors have suggested that the analysis, should be amended Agricultural Land Reform Act B.E. 2518 (1975). Section 16 (9), (12) and Section 30 (Fifth paragraph) as well as improve Regulations of Agricultural Land Reform Executive Committee with the assignment Secretary-General of Agricultural Lan Reform Office. Consider land permits for public utilities and other businesses in Land Reform B.E. 2536 (1993) and Regulations of Agricultural Land Reform Executive Committee with the rules, method and conditions to allow and the license to practice in the Land Reform or real estate for a supportive enterprise or related to the reform of agricultural land B.E. 2541 (1998) by incorporating them into some regulations and improve the text more appropriate.
