ABSTRACT

This thesis studied the sanitation and hygiene problems in the home healthcare business, the section of the registration of home healthcare business and the remedy of damage.

Results from the study found that the key in causing problems in the registration of home healthcare business and the remedy of damage was the home healthcare business Act B.E. 2016 and law or other relevant rules, there were gaps and inconsistencies. By asking for permission to operate a massage business, needs to ask for a license from the municipal office or the local District Office before asking for a license to operate a business establishment for health with the Department of Health Service Support, Ministry of Public Health. According to the rules of municipal law for massage, it has determined only spa business and massage for health that needs for a license under this municipal law. Therefore, if the business needs a license of massage for beauty, it can be seen that the principle of municipal law was inconsistent with this Act. The problem was the licenses issued may not be consistent with the license of the Department of Health Service Support and confusing to those who request service.

In addition to that, section 3 (2) of this Act did not specify the definition of massage for health or beauty clearly. Thus, those who apply for a license could not identify what type of business they would ask for the license, a massage business or massage for health and beauty.

As a result, those who ask for the licenses could not be identified in the application of business that they operate as a kind of massage. As a result, the staff could not get a license for them.

The qualifications of those who ask for the license of health established under this Act as the basic qualification. When compared to the United States, we will see that the laws of the United States have defined the qualifications of those who will ask for the license more concisely. The people who ask for the license must have a professional license related to health business, so they can ask for the license to operate a business.

Finally, the author suggests that this Act did not define the remedies of the damage. If damages arise from the use of the service in health establishments, then the victims must go to accuse a case to the court or accuse to the consumer protection board to request remedies for the damage. It might cause delayed remedies or might have to pay the operating cost but consider the legislation of the Republic of Singapore which requires people asking for a license must be deposited to be the collateral damage that will occur from filing a licensing procedure. So those who have been damaged can claim the refund guarantees in this section in order to immediately get damaged heal.

Thus, this thesis proposes that the law should define a local secondary legislation in accordance with the Act of the establishment of health 2016. And it should amend the definition between the massage for health and massage for beauty clearly. Moreover, it should amend the law regarding the qualifications setting of those who would ask for the license for the establishment of health. By requiring the user asking for the license establish to health must have a professional license in connection with the establishment of health before, so they can ask for the license. The law should be improved in terms of collateral damage in the process of obtaining a license as well as should amend the law to place collateral damage in the process of obtaining a license to those that have been damaged can get the security deposit immediately. And those who come to the establishment of health have been properly secured by the government can control the establishment of health to be the effective business as the spirit of the law.
