### **ABSTRACT**

The objectives of this study are to study and collect the methods of investigation and inspection of the cars suspected to be the cars put on carcasses of the cars after accidents, to study about the movement of stealing cars, putting on carcass license and the movement of bandits in stealing cars, putting on carcass and selling of the cars, and to propose a guideline to remedy and improvement of the protection measures and legal punishment for stealing cars and motorcycles, and controls of transactions of the carcasses obtaining from the accidents.

The method of studying was done by studying technical documents and interviewing with some highly qualified persons, and analysis of the methods of putting on carcasses, methods of stealing cars and motorcycles to put them on the carcasses obtaining from the accidents, and analysis of enforcement of the laws and legal measures in prevention and suppression of stealing cars and motorcycles in the past and at present in order to be a guideline to the prevention and controls of wrong doing in various forms as well as proposing a guideline to the remedy of putting on carcasses problems and improvement of legal measures to be more efficient in order to prevent the stealing of cars and motorcycles at present and in the future.

The results of studying found that stealing of cars and motorcycles to put on the carcasses for selling has been increasing every year since cars and motorcycles are movable properties which have quite high prices and also still be required by the neighboring countries.

When a car has been stolen, there shall be different processes of selling such as disassembly it as components and spare parts, bring it to put on the carcass obtaining from the accident or bring it to be used by putting on the car license and etc. All this is due to the laws which are used to control those wrong doings have light legal punishment and enforcement of the laws has inadequate efficiency which bring about troubles in the society, making the criminals not scare of the laws of the country, in combination with lacking of knowledge and understanding of the police officers in the movement of wrong doings of the criminals. And should there be permission to sell the cars obtaining from the accident the mentioned problems shall not be able to be vanished. While in foreign countries when a car got accident it shall be dumped or sold out since the cost of repairing is higher than buying a new car, and the cars of which their service life is longer than 4 years their tax shall be increased for many times in order to limit the number of the cars and prevention of pollution may occur. The legal measures, which have been used for a long time without amendment and improvement to be in harmony with the economical environment and changing society, have made many legal gaps for which the wrong doers can use them as channels to avoid the laws.
