ABSTRACT

This research aimed to 1) to factor the cooperation between A Public Sector and A Civil Sector in the rehabilitation of Drug Addiction Education in the area Nakhon Sawan Province 2) to examine the consistency of the causal relationship model of factors influencing cooperation between A Public Sector and A Civil Sector of Drug Addiction Rehabilitation Nakhon Sawan Province 3) to study the weight of direct influence Indirect influence And the combined influence of causal factors on cooperation between A Public Sector and A Civil Sector. Drug addiction rehabilitation Nakhon Sawan Province 4) study cooperation in the preparation of public services on drug addiction rehabilitation treatment The sample group was 285 officers under the Office of the Nakhon Sawan Pinit Institute and the Nakhon Sawan Provincial Police Division of the Provincial Police Division. The instrument used for data collection was a questionnaire of the approximate measurement type, divided into 5 levels by studying independent variables. This is the general information of the respondents and the factors of cooperation between the government and the community in the preparation of public services on drug addiction rehabilitation treatment in Nakhon Sawan Province. 6) Process management 7) Action results The statistics used to analyze the data are percentage, mean, standard deviation. And multiple regression analysis

The analysis results showed that

Make a diagram or picture showing clearly the steps of the planning process ($\bar{X} = 4.49$, $SD = 0.48$) and make a plan for development and reinforcement. Potential personnel To prepare for the future senior management ($\bar{X} = 4.42$, $SD = 0.49$), respectively, factors, guidelines, cooperation between the government and the community in the preparation of public services on drug addiction rehabilitation in Nakhon Sawan area, strategic planning The overall picture is at a high level. Factors, guidelines for cooperation between A Public Sector and A Civil Sector in the rehabilitation of drug addicts . Strategic planning Overall, the overall level was at a high level ($\bar{X} = 4.48$, $S.D. = 0.51$), with the organization heading to clearly define performance indicators and goals for each of the performance indicators ($\bar{X} = 4.55$, $S.D. = 0.47$), followed by Work plan / project Is consistent with the policy Organizational objectives and goals ($\bar{X} = 4.52$, $SD = 0.51$) Organizational plans / projects are conducted in the form B of committees from all workgroups of the organization ($\bar{X} = 4.51$, $SD = 0.53$). There is continuous improvement in service quality. It is in the annual action plan ($\bar{X} = 4.51$, $S.D. = 0.53$) and the organization has a clear vision ($\bar{X} = 4.39$, $S.D. = 0.47$).

2) Factors Guidelines for cooperation between A Public Sector and A Civil Sector in the preparation of public services in drug Addiction Rehabilitation Treatment in Nakhon Sawan Province on the importance of service recipients and stakeholders Overall, it was at a high level ($\bar{X} = 4.48$, $S.D. = 0.51$), with the overall topic at a high level ($\bar{X} = 4.47$, $S.D. = 0.52$). Experience and exchange ideas in various areas of work such as innovation, regulations, orders, laws, programs ($\bar{X} = 4.59$, $SD = 0.43$), followed by promoting and learning to understand the principles of sufficiency economy

and applying them to Live life of Nakhon Sawan Police Department officers and Nakhon Sawan Provincial Police Division with dignity ($\bar{X} = 4.48$, $SD = 0.53$), organize new knowledge training and organize a subgroup meeting to Opinions were expressed and the results of the meeting were expanded for the staff in the organization to apply in the work efficiency ($\bar{X} = 4.45$, $SD = 0.46$), providing a platform for exchanging knowledge through experiences. From operation Training development ($\bar{X} = 4.42$, $S.D. = 0.59$), respectively.

3) The factors of cooperation between A Public Sector and A Civil Sector the government in the preparation of public services on drug addiction rehabilitation treatment in Nakhon Sawan Province in 1) Measurement, analysis and overall knowledge management were at high level ($\bar{X} = 4.49$, $SD = 0.51$) by topic of Establishment of Working Group for Control, Supervision, Monitoring and Evaluation Working system development And performance reports are consistent with the annual action plan ($\bar{X} = 4.56$, $S.D. = 0.41$). respectively. 2) Terms of Human Resource Commitment Overall, it was at a high level ($\bar{X} = 4.48$, $S.D. = 0.49$), with the topic that the personnel of the organization were willing to sacrifice their physical and intellectual strength in the work at the organization ($\bar{X} = 4.56$, $S.D. = 0.43$) Organizational personnel believe in and accept the Organization vision and goals and are committed to action ($\bar{X} = 4.41$, $SD = 0.59$), and municipal personnel are proud to work in the organization ($\bar{X} = 4.40$, $SD = 0.58$) 3) Process Management Overall, it was at a high level ($\bar{X} = 4.48$, $S.D. = 0.51$) with the topic of performance, personnel of the organization adhered to regulations. or Strict Organizational Regulations ($\bar{X} = 4.52$, $SD = 0.48$), followed by the organization with a short chain of command, making it easier and faster to contact and coordinate ($\bar{X} = 4.51$, $SD = 0.45$). Flexible mounts can be modified to accommodate various changes ($\bar{X} = 4.48$, $SD = 0.55$). The organization has various compensation systems focused on both group and individual levels ($\bar{X} = 4.46$, $SD = 0.51$) and the organization assigns responsibilities to personnel to operate independently to their full potential ($\bar{X} = 4.43$, $SD = 0.55$), respectively 4) Results of Action The picture is at a high level ($\bar{X} = 4.45$, $S.D. = 0.58$) with the topic of operating the organization's plans / projects.
